**II. PARENTING TIME / VISITATION SCHEDULES:**

**B. Major Holidays and Vacation Periods**

**THANKSGIVING:**

(    ) Mother or (    ) Father shall have the minor child(ren) in all odd numbered calendar years, commencing at 6:00 P.M. on the Wednesday preceding Thanksgiving Day and ending at 6:00 P.M. on the following Sunday.

**CHRISTMAS VACATION:**

(    ) Mother or (    ) Father shall have the minor child(ren) during even numbered calendar years, for the first part of Christmas vacation from the day and time school is dismissed until December 25<sup>th</sup> at 3:00 P.M.

(    ) Mother or (    ) Father shall have the minor child(ren) during even numbered calendar years for the last part of Christmas vacation from 3:00 P.M. on December 25<sup>th</sup> until 6:00 P.M. on the evening before school resumes.

(    ) Mother or (    ) Father shall have the minor child(ren) during odd numbered calendar years, for the first part of Christmas vacation from the day and time school is dismissed until December 25<sup>th</sup> at 3:00 P.M.

(    ) Mother or (    ) Father shall have the minor child(ren) during odd numbered calendar years for the last part of Christmas vacation from 3:00 P.M. on December 25<sup>th</sup> until 6:00 P.M. on the evening before school resumes.

**SUMMER VACATION:**

Definition of summer vacation period: **The period of time from the day the child’s school recesses at the end of a school year until the day before the child’s school begins for the following school year.**

Mother and Father shall each have a two-week unbroken period of time in June and a two week unbroken period of time in July.

If the parties cannot agree, the ( ) Mother **or** ( ) Father shall have the period beginning at 6:00 P.M. on the first Friday in June and ending two weeks later on Friday at 6:00 P.M.

In July, the ( ) Mother **or** ( ) Father shall have the period beginning at 6:00 P. M. on the third Friday in July and ending two weeks later on Friday at 6:00 P.M.

The ( ) Mother **or** ( ) Father shall have the period beginning at 6:00 P.M. on the third Friday in June and ending two weeks later on Friday at 6:00 o’clock P.M.

**IF THE PARTIES CANNOT AGREE, THE FOLLOWING SUMMER VISITATION SCHEDULE SHALL APPLY:**

Each year, the Mother shall have summer visitation with the child for the period beginning at 6:00 P.M. on the day school is recessed for the summer vacation period and ending at 6:00 PM on the Saturday before Father’s Day.

Each year, the Mother shall also have the period beginning at 3:00 P.M. on the first Saturday in July and ending two weeks later on Saturday at 3:00 P.M.

**SPRING VACATION** (if applicable):

Definition: The child’s spring break from school.

The Father shall have the child(ren) in all even numbered calendar years from 6:00 P.M. on the day the child(ren) is/are released from school for said spring break until 6:00 P.M. on the day before the child’s school resumes after the end of spring break.

The Mother shall have the child(ren) in all odd numbered calendar years from 6:00 P.M. on the day the child(ren) is/are released from school for said spring break until 6:00 P.M. on the day before the child’s school resumes after the end of spring break.

**FALL VACATION** (if applicable):

Definition: The child’s fall break from school.

The Mother shall have the child(ren) in all even numbered calendar years from 6:00 P.M. on the day the child(ren) is/are released from school for said fall break until 6:00 P.M. on the day before the child’s school resumes after the end of fall break.

The Father shall have the child(ren) in all odd numbered calendar years from 6:00 P.M. on the day the child(ren) is/are released from school for said fall break until 6:00 P.M. on the day before the child’s school resumes after the end of fall break.

**E. Start and end dates for holiday visitation:**
